Guidelines

E- Poster Presentations

- Presenter should be registered for the International Digital Dentistry and Implantology Conclave 2022
- E- Poster has to be a single slide in Powerpoint and may contain any number of animations.
- There can be a maximum of 3 authors (one presenting author and upto 2 coauthors) in an E-Poster. They cannot be the chief authors/co-authors for more than one presentation.
- Topic: Anything related to Digital Dentistry or Implantology.
- E-poster can be submitted under 3 options Faculty or Student or Clinician
- Your structured abstract and e-poster should be submitted under one of the following categories:
 - Original Researches: The abstract headings for which should be as –
 Introduction, objectives, methods (including statistical methods where
 relevant), results, conclusions.
 - Case reports: The abstract headings for which should be as –Introduction, case characteristics (patient's age, gender, clinical presentation), outcome (diagnosis, treatment), discussion, conclusion.
 - **Reviews:** The abstract headings for which should be as -Background, methodology, discussion, summary, conclusion.

SUBMISSION AND UPLOADING OF ABSTRACT

- The structured abstract should be submitted not exceeding 250 words.
- The author/co-authors names, title, Institution name and contact details should be stated clearly in the abstract.
- The abstract of the published articles and unfinished researches will not be accepted. It should not have been submitted or accepted at any other state, national or international scientific meeting.
- Abstracts with plagiarism will not be accepted.
- Abstract are to be submitted online only. No abstract shall be accepted as e-mail, fax, hard copies etc.
- Last date of submission and uploading the abstract along with the e-poster is 25th October 2022.

SUBMISSION AND UPLOADING OF E-POSTER

- The title of e-poster should be condensed based on the main aim of the poster not exceeding 100 characters (including spaces).
- Include all the authors names in the poster. Names of guiding staff or HOD or college name should not be mentioned on the poster. Mention of any such names would amount to disqualification of the poster.
- Use Time New Roman or Arial fonts.
- Use clear headings and leave spaces between sections. Pictures and graphics should be of good quality, clearly labelled and described.
- Posters should be understandable to the viewer without verbal explanation. It should have a clear structure and layout with minimum amount of text. It should be easily readable from a distance of 5 meters.
- Presentations should be in one ppt slide (Microsoft PowerPoint). The Page setup
 / size is 16:9, 1080resolution, Max size 10Mb, JPEG Format. Orientation:
 Landscape mode. Do not use slide transitions, animations files, movie or sound links
 in the ppt.
- A link to upload abstract and E-Posters is available on the website. Last date for submission and uploading of abstract and e-poster is 25th October 2022. E-posters submitted after the last date shall be automatically rejected.
- The selected E-posters for presentation will be informed via E mail by 30th October 2022.
- FINAL POSTER SHOULD BE SENT BY 15TH NOVEMBER.
- Carry the soft copy in Pendrive as a backup in case of technical issues.
- The e-posters will also be displayed in the kiosk for the other delegates to view any time during the conference. Each poster will be displayed for 1 min and all posters will be run in an endless loop.
- The scientific committee reserves the right not to consider the e-poster that does not comply with the above specifications.

PRESENTATION AND SELECTION

- Date and timings of E-poster presentation and judging session will be notified on the website/ E mails.
- The Presenting author &/or co-authors will need to be present next to their e-poster during the judging session.
- Each presenter will get only **3 minutes** for presentation followed by **2 minutes** for question-and-answer session.

- Marks shall be provided by the judge and the poster shall become eligible to contest for an award and certificate only if the author and co-authors are present at the time of judging.
- All the selected best posters will be presented again in the Best E-Poster Awards session.
- Acceptance of poster is at the discretion of the ISDD Board.
- The decision of the scientific committee is final and binding in all situation.
